

IMPORTANT TERMS & CONDITIONS OF SALE

PROSPECTIVE BIDDER/BUYERS MUST READ

20% BUYER'S PREMIUM WILL BE APPLIED TO ALL PURCHASES IN THIS AUCTION.

This is an ONLINE ONLY bidding platform. Preview before bidding is required by prospective buyers or their agents. All sales are FINAL and all lots will be sold AS IS. All lots must be paid for immediately and before any paperwork is processed.

All firearms transfers will be in strict accordance with all international, Federal, State and local laws. Be sure to check your country, state and local laws before bidding. If you are unable to import, purchase, or own a firearm according to your residency laws, do not bid on these items. If you bid and find out later you cannot legally own/accept delivery, the bid is still a valid contract that the buyer must pay. Opfer Auctioneering will not cancel the sale due to disapproval for any reason.

All items sold are subject to Federal and State regulations. All modern guns must be registered. Gun registration is handled by Duffy's Gun Room, 15433 Falls Rd, Sparks Glencoe, MD 21152. Opfer Auctioneering is not, nor will be held responsible if the buyer fails a background check and are ineligible to possess a firearm. If this situation arises, Opfer Auctioneering will not issue a refund, but we will allow for the ineligible buyer to consign to Duffy's Gun Room to re-sell, for a commission, on behalf of the winning bidder. All guns requiring registration MUST be picked up at Duffy's Gun Room,. All guns requiring registration will be delivered to Duffy's Gun Room on the night of the auction for registration and retrieval. In-State Buyers will pick up at Duffy's Gun Room: 15433 Falls Road, Sparks, MD 21152. Out of state buyers will supply Duffy's Gun Room with FFL License, and Duffy will ship to that licensed agent. Insurance may added onto registration fees when shipping.

All handguns are subject to \$100 transfer/registration fee, up to 60 days storage, and buyers must be 21 years of age or older.

All long guns are subject to \$50 transfer/registration fee, up to 60 days storage, and buyer must be 18 years of age or older. *There appears to be a new Maryland long gun law which may or may not be in effect at the time of the auction.*

All Class 3 guns are subject to \$500 transfer / registration fee; class 3 has taken up to 9 months for approval. No guarantee as to length of approval time. \$500 covers up to 9 months of storage at Duffy's Gun Room. Buyer's must be 21 years or older to purchase.

Dealers and Individuals that bid on and win NFA (National Firearms Act Class III) or DD (destructive devices) items own the items and are fully responsible for payment within terms regardless of whether they are approved for taking physical possession of the items. Opfer Auctioneering will not cancel the sale due to BATF disapproval for any reason.

Ammunition will be picked up at the 1919 Greenspring Drive location, and you must be 21 years of age or older to purchase.

Antique and some guns (so noted on the auction listing) can be picked up at Opfer Auctioneering.

There will be no options for refunds of any type beyond 15 calendar days from the auction date. Paying late and thus receiving items late will not change the limitation on the dates above for refund consideration.

Since all firearms sold are "collectible" items, Opfer Auctioneering does not test the safety or warrant functionality of these firearms. All firearm purchases should be examined by a certified gunsmith prior to shooting. Neither seller nor auctioneer express any warranties concerning fitness for use, safeness to fire, to store, or reliability of any firearm, ammunition, parts, parts or components of any lot.

Opfer Auctioneering reserves the right to deny the sale of a firearm to any buyer.

In the case of a disputed bid, our Auctioneer will determine who the successful bidder is or re-offer and resell the disputed item
